Montevallo City Council Work Session April 13, 2015 5:30 p.m. at City Hall

Mayor Hollie Cost, Council members Willie Goldsmith, Jason Peterson, Rusty Nix, and Dee Woodham were in attendance. Council Member Gilbert was absent.

Mayor Hollie Cost called the work session to order at 5:30 p.m.

A representative from Great Western Retirement Services informed the council about recent federal legislation allowing cities to adopt an RSA-like plan which is a free, federally-funded retirement program in which employees may pick and choose their investments. The program also calculates employees' needed pension and social security savings and offers flexible deferment options. The finance committee agreed that this plan is very beneficial to city employees and has no real drawbacks.

Court Magistrate / Clerk Ivy Krukowski presented information on a software package which would allow traffic law offenders to pay their tickets online at a rate of 3.5% of the ticket amount. Offenders will be notified of this online fee at the time of payment and may opt-out if they choose (in which case they must pay the ticket in person). Surrounding cities such as Alabaster use this software package as it charges offenders at a reasonably competitive rate (other service providers charge up to 11% of the ticket amount). The software is a one-time purchase and requires no contract.

Our Code Enforcement Officer, David Holloway, presented the Housing Abatement Board's top five properties within the municipality that need to be torn down or repaired. He needs to know the budget for taking down or repairing said houses. City Clerk Lehman pointed out that it cost \$4,600 to remove a house last year, but that figure was on the low-end. The Council broadly estimated \$6,000 per house removal this year and speculated the county may help with debris removal.

The properties discussed included:

- 1) 320 Selma Road (The Burned Out house)
- 2) 613 Shelby Street
- 3) 171 Commerce Street
- 4) 23 Motley Ave
- 5) 1171 Spring Creek Road

The Board needs the council to approve the funding available for the destruction of the buildings. Once the Council approves the funding, letters will be sent to property owners requesting action and giving a timeline. If no action is taken we will move ahead with the abatement process.

Denise Arceneaux is teaming up with her father, Don Robuck to build a farm that will grow up to 25 greenhouses supplying upwards of 450,000 pounds of fruits and vegetables per year. Denise's passion has been in health and nutrition although her work background has been in business training. Her vision extends past the food production to the individuals who are sick and in need of food for medicine. Her husband, Cliff is a Physician Assistant obtaining a Plant Based Nutrition Consulting certification to help with his Doctor's office. Their vision includes integrating this as an extended service to the community. Don's background has been in home building and custom interior trim, always a business owner. His switch to a plant based diet fueled an interest in understanding how to grow produce to provide for his family. As he learned more about the sustainability of aquafarming and the need for more food per acre in the farming industry he knew he had found something that was needed not only in his local community but also in the state of Alabama. In their conversations with local grocery stores and restaurants as well as friends and family they know there will be no shortage of clients for their produce. They have partnered with an expert in the field, Doug Burdette who is providing the construction plans and consulting in the daily activities and needs for the farm. With his 40+ years in aquafarming they know they are in safe hands.

With Montevallo's interest in teaching sustainability and farming to the surrounding schools and community this can be easily provided on city land. By leasing the land in Montevallo Incredible Health Farms has the location it needs to provide produce to Birmingham and Montgomery restaurants, schools, locals and grocery stores. The forward thinking community of Montevallo matches well with their vision to help both community and individuals with better health.

### Capital Account Start up Cash Flow

This is **THE EXPENSES OF INCREDIBLE HEALTH FARMS NOT THE CITY OF MONTEVALLO.** This shows you what they have invested in the startup. This also depicts the order of construction based on the need and operating income. The first construction will be the fish house with two tanks. One tank is dedicated to the fingerlings (baby fish) and as they grow they will be moved to the next tank where their waste will be filtered through the system to provide nutrients for the vegetables. It takes 4 months for this process to produce enough nutrients for the first greenhouse. While the fish are growing the first greenhouse will be built and the first crop will be germinated. Greenhouse 2 through 5 will be built in year 2. This document shows the fish operation costs, construction costs, bank balance along with management expense when needed the second year.

### **Full Growing Operations Projections**

This spreadsheet looks complicated at first glance. There is a great deal of calculations combined on one sheet to give the overall picture of the first three years. The dates will change depending on when the farm starts so pay little attention to the dates. Cash from Capital is funding operations until the sale of the fish and produce which begins at 6<sup>th</sup> month with the sale of fish. The green highlighted numbers in the Income column represents income from the greenhouses and they darken as additional greenhouses are added.

### Assumptions that were made in these numbers:

- Sale of fish \$3/lb. which fluctuates with the market
- Sale of tomatoes \$3/lb. certified organic heirloom Cherokee purple
- Cost projections of daily operations .80/lb. based on Doug Burdette's projections then compared to Mississippi State's cost of tomato production
- All numbers are based on a greenhouse of heirloom Cherokee purple tomatoes because they are in high demand and extremely low supply. As supply and demand fluctuates the farm intends to find the holes in the market and fill in those holes.
