Chief Reid stated that there was a discrepancy in the report regarding the total number of incident calls. He had calculated a total of 1203 calls although the report states 1180 and is unclear why the discrepancy exists. He noted the majority of the calls were medical related. Chief Reid continued that the month of January had started off busy with numerous calls but had slowed down in the last week. Chief asked for approval of a bill in the amount of \$2,000 for equipment relating to the diversified certification of the ladder truck. He also reported that grant money had been received for the Snorkel truck.

Mayor Cost thanked Chief Reid for his report and acknowledged the great volunteers of the Fire Department who work tirelessly for the community. She said all the volunteers were in need of recognition for the City's appreciation and would like to acknowledge Kevin Harris for his service on 239 calls this past year. The Mayor noted that the City Council members are welcome to stop by the Fire Station at any time to visit the volunteers and staff. Fire Marshall Brandon Broadhead also noted that any Council member that wanted to receive information about calls, text messaging service could be arranged. Mr. Broadhead stated that a volunteer training certification course would be held on February 1, 2016 and a tentative date of January 30, 2016 had been set for a demonstrated house burn.

Fire Marshall Broadhead reported that there was a 150% increase in general inspections this year. All details are reviewed in each building process and he is working towards all businesses being up to code. Mr. Broadhead noted that priority is keeping all businesses open and understands that the codes may not have been previously enforced and businesses may need to time to comply. Mr. Broadhead noted the completion of the new Middle School entrance and that he communicates frequently with representatives from the County on all building inspections. Mr. Broadhead then updated the Council on the new truck that he picked up last month. The truck was currently in the lighting shop and should be on the road in service soon.

Hershel Hale, Chair of the Arbor and Beautification Board, stated that Arbor Day is scheduled for the last Saturday in February, and requested the approval of the following proclamation regarding Arbor Day in order for the City to qualify as a tree city. Mr. Hale also discussed the Beautification Month Resolution that would declare the month of April 2016 as Montevallo Beautification Month.

The Arbor Day Proclamation was presented as follows:

ARBOR DAY PROCLAMATION

In 1872, J. Sterling Morton proposed to the Nebraska Board of Agriculture that a special day be set aside for the planting of Whereas, trees, and the holiday, called Arbor Day, was first observed with the planting of more than a million trees in Nebraska, and Whereas, Whereas, Arbor Day is now observed throughout the nation and the world, and trees can reduce the erosion of our precious topsoil by wind and water, lower our heating and cooling costs, moderate the Whereas, temperature, clean the air, produce oxygen and provide habitat for wildlife, and trees are a renewable resource giving us paper, wood for our homes, fuel for our fires and countless other wood products, and Whereas, trees in our city increase property values, enhance the economic vitality of business areas, and beautify our community, and Whereas, trees, wherever they are planted, are a source of joy and spiritual renewal, Whereas,

NOW, THEREFORE, We, the Mayor and City Council of the City of Montevallo, Alabama, do hereby proclaim Saturday, February 27, 2016 as ARBOR DAY in the City of Montevallo, and urge all citizens to celebrate Arbor Day and to support efforts to protect our trees and woodlands, and

Further, we urge all citizens to plant and care for trees to gladden the heart and promote the well-being of this and future generations.

Hollie C. Cost Mayor Herman F. Lehman, III City Clerk Mr. Hale continued that he was happy to see the structures coming down that have been a nuisance in the community. Mr. Hale then requested that the Council consider the request of Mr. Norman McMillian to plant a tree in Orr Park in memory of a dear friend. Mayor Cost asked that the item be placed on the Council meeting agenda under Other Business for vote by the Council and thanked Mr. Hale for his work.

Mr. Kirk Hamby, Director of Public Works, stated that he and his crew were thankful that the rain had held off and was hoping for no severe winter storms. He continued that his crew has resumed normal routine following the rush of the holiday season. He noted that seven truckloads of metal and aluminum had been removed from the city yard. Mr. Hamby stated that the sculptures that were in place in front of the Elementary School before construction of the new entrance will be returned to town in the next week and would be stored at the Recycling Center. He stated that some of the sculptures were in need of restoring and he is entertaining all ideas of how these sculptures can be utilized in the City. Mayor Cost clarified that the sculptures were ones created by University of Montevallo students based on drawings from children in our Sister City. Mayor Cost also noted that ideas for locations for the sculptures included the park and library and all ideas are welcome. Mr. Hamby stated that he would like to remind the citizens of the wonderful City cemetery that is available. Mr. Hamby continued that the yearly average for burials in the cemetery were twenty-five to thirty; however, eleven burials had been completed in the month of December. He continued that the City is proud to offer a final resting place in the City to its citizens. Mayor Cost stated that she had received a very nice letter from Mr. Ed Robertson upon the death of his wife regarding the good work of both Mr. Hamby and the cemetery crew as well as the Police Department. Janice Seaman, citizen, asked if there were any remaining plots in the cemetery. Mr. Hamby answered that the cemetery still had lots of spaces available and is currently charging a rate of \$1200 per plot.

Mayor Cost thanked Mr. Hamby for his report. She noted that the Vallocycle Committee would meet on Thursday, January 21.

Mayor Cost then asked Mr. Hamby to update the Council on Parks and Recreation as Mr. Shane Baugh could not be present for the meeting. Mr. Hamby stated that he was aware that youth basketball was ongoing and early bird registration for youth baseball and softball would be occurring next week.

Dwight Dellinger presented information regarding the Golf Course. Three hundred and eighty one rounds had been played this past year, down from the previous year of four hundred and twenty nine rounds. November numbers were low due to the weather and rain but had established two new memberships. Mr. Dellinger reported that they were gearing up for spring tournaments and he had talked with the Montevallo Chamber as well as Kelsey's Place out of Clanton regarding the hosting of their events. Mr. Dellinger spoke with Sandy Byrd at City Hall about posting flyers and advertisements on the City's website regarding the upcoming tournaments. Mr. Dellinger stated that the cold weather and frost on the ground had delayed the opening of the course and appreciates the efforts of Clay and his team for the good work of maintaining the greens. Mr. Hamby added that the restrooms at the Golf Course were almost complete with the heater installed and now awaiting service from the power company.

Council Member Nix stated that he had walked the trails and they looked good. He stated that there was graffiti in a few places that would need to be removed, including an area on the bridge and on the brick pilings. Mr. Nix also reported that he viewed an issue with the sewage line crossing the creek in which it looked like logs from high water had hit the pipe and knocked the concrete pier making the line unstable. Mr. Nix

noted that the Water Board was aware and they would be meeting Wednesday at 9:00 am. Mayor Cost thanked Mr. Nix and asked City Clerk Lehman to attend the Water Board meeting on behalf of the City.

Janice Seaman, Chair of the Historical Commission, reported that end of the year funds included approximately \$1164 in the J.A. Brown Memorial fund and approximately \$11,000 in the Historical fund from awarded grants which would be used on archeological work at Shoal Creek Park, having the Mahler property added to the Historic registry, designating a Street Historic District, and educational presentations.

Mayor Cost asked City Clerk Lehman to read Council Member Gilbert's report in her absence. The report was read as follows:

Montevallo High School started a Wrestling Program in December. The first match was December 15th. Report card conferences will be held at Montevallo High School the week of January 11th. Members of the Future Teachers of America (FTA) from MHS will serve as teacher's aides for the middle and high school.

Ms. Williams noted that the increase in deposits was due to the 1st quarter State aid which was received and deposited at the end of December. Ms. Williams provided information regarding upcoming events including the Lego Club meeting that would be held on January 22 and the Chess Club would meet on January 23 as well as the English classes had resumed and are held on Thursday's at 5:45 pm. She updated the Council that the books received from the non-fiction grant had been processed and 90% are on the shelf, which included about 300 new books available to the public. She also reminded the Council that this particular grant required payment upfront and all funds would be reimbursed.

Janice Seaman, Chair of the Industrial Development Board announced that discussions had occurred with individuals who were interested in purchasing the House of Serendipity property. The proposed buyers were requesting that the City waive all tax fees for three years for a total of approximately \$2100 as yearly annual property tax totaled \$700. City Clerk Herman Lehman explained that the majority of the tax were that imposed by the County, State, and School tax and that a small portion of that amount was actually local tax. Mayor Cost asked City Clerk Lehman to assist in determining the correct process to request a tax waiver from these other entities for the benefit of the City for the property to be purchased. City Clerk Lehman agreed to assist in determining the best course of action. Council Member Nix asked Ms. Seaman if any information regarding the proposed business was available. Ms. Seaman stated that the purchasers were interested in restoring the building and opening the space for lease. She continued to report that a structural engineer did review the property and found it to be structurally sound. The property is in need of repair but is restorable. Fire Marshall Broadhead asked Ms. Seaman for a copy of the report as he works with the County to ensure the property is up to code. Mayor Cost stated that the Council would not be able to vote on the request regarding taxes until further information is obtained but would state that she would be in favor. Ms. Seaman also noted that discussions were in place with Dr. Caplow at the University of Montevallo to have intern students assist with growing and providing tomatoes and lettuce to the University cafeteria for consumption from the Community Garden.

The Work Session concluded to begin the City Council Meeting.

Demolition of Three (3) Unsafe Buildings / Structures Deadline for Submittal: Friday, January 8, 2016 at 1:30 pm CST owner would be required to clean up the property and deem the property safe as required by code. Mayor Cost noted that if possible it is in the interest of the City to save historic homes. Council Member Nix asked what the legal ramifications would be if the demolition was postponed on the Shelby Street property. Officer Holloway stated that he was contacting Mr. Justice, City Attorney, to determine on what date the City actually takes possession of the property. Janice Seaman, citizen, addressed the Council to announce her intention of purchasing the home on Shelby Street and had secured a signed contract on the property with a closing date set for Tuesday, January 19. Ms. Seaman noted that the City would save approximately \$9,000 in demolition fees due to her purchasing the property for restoration. She stated that the property had historical value and was constructed before the Civil War and was designed by the Wilson brothers of Wilson's Hill. Ms. Seaman stated that if the Council would suspended voting to demolish the property and allow her time to secure the purchase of the home, she would finalize all paperwork and purchase a building permit to submit to the Council her intentions of restoring the home. City Clerk Lehman noted that the Council could delay the vote on this particular property until the next Council meeting and move forward with a vote on the other two structures. Mr. Greg Reese, member of the Abatement Board, stated that he would be glad to see the home saved, however he was concerned with the fact that the house has been deemed a danger and the restoration projects would need to begin quickly. Ms. Seaman stated that the home had been inspected by a structural engineer and had been deemed structurally sound. Officer Holloway explained that in regards to code enforcement the trash and debris on the property would have to be removed quickly. Ms. Seaman stated that the seller of the property had agreed to take care of that by the end of January as a provision to the contract. Mayor Cost recommended a motion to award the bid to the low bidder for the other two structures located on Commerce Street and Selma Road and delay voting on the structure located on Shelby Street.

Council Member Nix made a motion to award Cox Landscaping as the lowest bidder in the demolition of structures located at 171 Commerce Street and 320 Selma Street and delay the vote on the structure at 613 Shelby Street to the next Council meeting. Council Member Goldsmith seconded the motion. ALL AYES. THE MOTION WAS APPROVED.

Mayor Cost thanked Ms. Seaman for her interest in saving the structure and stated she was excited about the possibility of saving the history of the house. Mayor Cost confirmed that Officer Holloway and City Clerk Lehman would handle the notification of bid winners. Officer Holloway stated that review of other structures in the City in need of demolition is being conducted. Money is still available from the original allotment and he would like to keep the momentum going of improving the safety of the City by removing unsafe structures. He also stated the Fire Marshall would be making a report to the Abatement Board at the next meeting.

CERTIFICATE OF INCORPORATION OF THE CENTRAL VILLAGE MEDICAL CLINIC BOARD

KNOW ALL MEN BY THESE PRESENTS, That we, Ben W. McCrory, Kenneth Dukes, and Hollie C. Cost, each of whom is a duly qualified elector of and an owner of property in said City (or an owner of property located in Shelby County, Alabama in areas outside the municipalities located in said county), do desire to organize a body corporate under the provisions of Section 11-58-1 et seq., <u>Code of Alabama</u> (1975) as amended, and being all of the incorporators of the corporation hereby organized, do make, sign, execute, acknowledge and file this Certificate of Incorporation as follows:

FIRST: The name of this corporation shall be **"The Central Village Medical Clinic Board."** The location of the principal office shall be at City Hall of the City of Montevallo, 541 Main Street, Montevallo, Alabama 35115.

SECOND: The period for the duration of this corporation shall be perpetual except as otherwise limited by operation of law.

THIRD: This corporation is formed for the purposes of constructing, operating and leasing for operation, medical clinics, and to that end, said corporation shall possess all powers necessary, desirable and convenient to conduct the said operations and to carry out the purposes herein expressed and all those expressly conferred upon public corporations under the provisions of Section 11-58-1, et seq., Code of Alabama (1975), as amended, and also, in addition to the above powers, shall have the following powers which shall be construed to be complementary to and not as limitations of the preceding powers:

(a) To sue and be sued and prosecute and defend, at law or in equity, in any Court having jurisdiction of the subject matter and of the parties, whether State of Federal.

(b) To have and use a corporate seal and to alter the same suitably at its pleasure.

(c) To acquire, whether by purchase, exchange, lease, construction or otherwise, one or more medical clinics and any necessary or desirable clinical facilities including nursing homes, assisted living facilities, and domiciliary care facilities; provided, however, that any

such medical clinic shall be located either within the corporate limits of the municipality or within fifteen (15) miles of such corporate limits, but not within the corporate limits of any other municipality, and not within the police jurisdiction of any other municipality unless such other municipality shall by resolution adopted by its governing body consent to such location within its police jurisdiction; and provided further, that no medical clinic shall be located outside of Shelby County.

(d) To improve, enlarge, maintain, equip and furnish one or more medical clinics and any necessary or desirable clinical facilities relating to either of such facilities.

(e) To lease to others, one or more medical clinics or parts thereof and any clinical facilities and to charge and collect rent therefor and to terminate any such lease upon the failure of the lessee to comply with any of the obligations thereof; and to grant options to renew or extend any such lease upon such terms and conditions as the Board of Directors may determine; provided that no lease shall extend beyond the last maturity of any bonds issued by this public corporation or sixty (60) years from the date of the lease, whichever is the longer.

(f) To sell, exchange, and convey, to contract to sell, exchange or convey, and to grant options to any lessee to acquire any medical clinic and any clinical facilities in connection therewith, and any or all of its properties whenever the Board of Directors of this public corporation shall find any such action to be in furtherance of the best interests of the corporation and the purposes for which it is organized.

(g) To borrow money and to issue corporate bonds for the purposes of carrying out any corporate powers.

(h) As security for the payment of the principal of and interest of any bonds so issued and any agreements made in connection therewith, to mortgage and pledge any one or more of its medical clinics and any or all of its clinical facilities or any part or parts thereof, whether then owned or thereafter acquired, and to pledge the revenues, rentals and receipts therefrom or from any part thereof.

(i) To enter into contracts and agreements or to do any act necessary for, or incidental to the performance of the duties and the execution of its powers as herein provided.

(j) To accept gifts of money or property, including one or more medical clinics and clinical facilities, from any source whatsoever, subject to such conditions as the Board of Directors of this public corporation may approve.

(k) To appoint and employ such officers and agents, including attorneys, as may in the judgment of the Board of Directors be required.

(l) To provide for such insurance as may be deemed advisable by the Board of Directors of this public body corporate.

(m) To buy, sell, trade or otherwise dispose of any and all personal property which may be necessary, convenient or desirable in order to further the purposes of this public corporation, no matter when the said personal property may be acquired, sold, or traded.

<u>FOURTH:</u> All Directors hereafter shall be elected by the Council of the City of Montevallo by majority vote thereof. Initially, Directors of this corporation and the terms of office of each shall be the following:

The terms of the above listed initial Directors shall begin to run from the date of filing of this Certificate of Incorporation with the Judge of Probate of Shelby County, Alabama. All Directors thereafter elected shall have terms of office of six (6) years unless removed for cause. The Board of Directors shall elect the following officers from among their number: Chairman, Vice Chairman, Secretary-Treasurer, and Assistant Secretary-Treasurer. Duties of each officer shall be those required by law and those which may be assigned by the Board of Directors.

<u>FIFTH:</u> Special called meetings may be held when deemed necessary by the Chairman of the Board of Directors after reasonable notice to all members of the Board.

SIXTH: Officers and members of the Board of Directors, including the Chairman thereof, shall serve without pay.

<u>SEVENTH:</u> A report in writing covering financial and other matters shall be made to the Mayor and Council of the City of Montevallo once each year on the anniversary of the date of incorporation. The report shall cover activities of the Board during the preceding year.

<u>EIGHTH:</u> Any member of the Board who removes his residence or voting place from the City of Montevallo or who sells all of his property within the City of Montevallo shall be disqualified to remain on the said Board; it shall become the duty of any such Board member to notify the Chairman of the Board and the Mayor of the City of Montevallo in writing that he or she is no longer qualified to serve on the Board. Vacancies on the Board shall be filled by the Mayor and Council of the City of Montevallo in the same manner as vacancies on the Board caused by expiration of terms of office.

NINTH: With respect to any property owned by the Board but leased to a nongovernmental entity, the Board shall not avail itself of any exemption from ad valorem, sales or use taxes without the approval of the City Council of Montevallo, Alabama. Unless the City Council of the City of Montevallo, Alabama consents to the omission thereof, the Board will cause each lease agreement that it enters into with a non-governmental entity to include a provision that, notwithstanding any exemption from ad valorem, sales and use taxes to which the Board or user of the property may otherwise be entitled, the non-governmental entity will pay in lieu of taxes the amount that would otherwise be due to the City of Montevallo without such exemption.

Council Member Nix made a motion to approve the request for a tree planting as presented. Council Member Peterson seconded the motion. ALL AYES. THE MOTION WAS APPROVED.

Mayor Cost recognized Junior Council member, Price Alexander and asked if he had any updates or information for the good of the whole. Price announced that no Junior Council meetings had been held recently due to the holidays but meetings would resume soon. He also confirmed that he would be meeting with Mayor Cost following the Council meeting.

Citizen Participation

The Mayor again called for anyone in attendance to address the Council.

Ms. Betty Savage, resident at 109 Salem Road, stood and stated that she appreciates the hard work in cleaning up Montevallo, she has noticed men keeping the grass cut and everything is looking great around the City. Ms. Savage also noted her appreciation for involving the University and the work that has been accomplished from the partnership. She continued that what she did not like was the idea of the open container proposal. She stated that it does not make sense for our community, and she is worried about her grandchildren. Ms. Savage asked for confirmation that the public would be notified when the decision would come for a vote and additional information to be provided.

Mayor Cost explained that the idea of the Entertainment District with open container provision was proposed by citizens and as stated earlier there is a lot of information to work through. The Mayor stated her appreciation for all comments regarding the issue. Mayor Cost reiterated that the issue would not be voted on without public notification and input.

No other citizens expressed interest in speaking.

Adjourn

Council Member Nix made a motion to adjourn the meeting. Council Member Peterson seconded the motion. ALL AYES. THE MOTION WAS APPROVED. THE MEETING WAS ADJOURNED AT 6:28 pm.
