MINUTES

Montevallo City Council Work Session August 24, 2020 5:30 p.m. at City Hall

Mayor Hollie Cost, Council Member Rusty Nix, Council Member Arthur Herbert, Council Member Tiffany Bunt and Council Member Jason Peterson were in attendance. Council Member Willie Goldsmith was absent.

Mayor Cost called the Work Session to order at 5:34 p.m.

Fire Chief Brad Davis reported they responded to 120 calls in July, 92 so far in August. There were five fire calls and 52 EMS. They made 15 fire inspections in August.

Council member Herbert asked where Chief Davis would recommend placing storm shelters.

Chief Davis note we have temporary safety shelters at the High School and Aldrich Baptist Church.

Council Member Herbert asked if there is a need for additional shelters.

Chief Davis said the locations we use now are not FEMA certified shelters. He said we definitely need one.

Chief Littleton said he did not have a report. He just returned from a training class.

Council member Herbert reminded everyone about the Animal Health and Safety Forum scheduled for September 3rd at 6:00 p.m. via Zoom. He invited anyone interested to attend. He also invited them to send comments to mayorsoffice@cityofmiontevallo.com.

Mayor Cost noted this is not an official city meeting – it is an opportunity for our citizens to meet and discuss their concerns on this issue.

Council Member Herbert reported that the Arbor Board has reviewed the landscaping plans for the old Eclipse property.

Kirk Hamby, Director of Public Works, said the residents of Arden are upset due to the delaying in the repaying of their streets. The project should be finished by October 15th. He said he will keep the residents informed about the start date. We will also post the information on our website.

He said he's been assisting Officer Wilder with Code Enforcement issues. They've closed out six issues, and are still working on several more.

Sustainability Director Olivia Barone informed the council we are one of 84 communities nationwide to receive the AARP Challenge Grant. We received \$29,000 for the placement of accessible exercise equipment for Orr Park and Dailey Park. In addition, she pointed out we've received as quote for a new Bucket Truck to be used by our Leaf & Limb and Public Works crews. We propose purchasing the truck using a grant from the VW settlement which is administered through ADECA. The new truck will reduce the diesel emissions created by our current one by 93% and save us 10,000 gallons of fuel over its lifetime. Our 20% match on the purchase would be around \$30,000 and would come from the Sanitation Fund.

Shane Baugh, Director of Parks & Recreation, informed the Council our first football game is Saturday. We are testing the waters to see how it goes. October 3rd is our first home game. MHS plays Friday night ion Columbiana.

Soccer registration is way down this season. The Pelham YMCA has canceled all fall sports. That limits the number of teams we can play.

Council Member Nix reported that rounds are down at the Golf Course. Several of our carts are inoperable because we are having to replace the batteries.

The Planning Commission met last Thursday and approved Phase 7 of the Colonial Oaks development.

Library Director Savannah Kitchens presented her report:

- The library has officially launched our new storytime: Drive In Stories with Mr. Mac. Funded by the Parnell Memorial Library Foundation, these family storytimes happen in the library parking lot every Saturday at 9:15 with everyone's favorite performer, Mr. Mac. Tune in to the frequency to listen to stories and songs from the comfort of your car. Frequency is given out each Saturday when you pull up, to make sure it's available that day. As always, these storytimes are free to the public!
- In addition to Drive In Stories with Mr. Mac, and our weekly Facebook video storytime with Ms. Jennifer, we are about to launch a new Spanish-language virtual storytime. These are done by Trent Jones, and will be posted on our Facebook page quarterly. These storytimes are also funded by the Parnell Memorial Library Foundation.
- Our Family Literacy kits are ready to check out! We have different kits aimed at different age
 groups, including babies, Spanish language babies/pre-K, pre-k, early elementary, late
 elementary, Spanish language elementary, middle and Spanish language middle school. We
 also have kits focusing on helping meet specific reading needs, including sight words and
 dyslexia for both younger and older elementary age students. Kits include an ageappropriate hands-on activity, books, and parent resource.

- These are the kits we created with the Dollar General grant we received back in the spring, but we had no idea that they'd become even more important this year. Almost 20% of the entire student body of Montevallo Elementary School receives reading intervention, and we hope these kits can help supplement reading education.
- We're encouraging families to check out these kits as a way to spend some oneon-one time with your kids, reading and playing together – and in the process, help strengthen their literacy skills.
- Just a reminder we are still open for curbside services. If you don't know exactly what title you're looking for, call us and ask for a Book Bundle, we'll put something together for you based on your preferences.
- And last: we have a new direct phone number: (205) 667-3052. The old extension number will still get to us, but this one is just a simpler way to get ahold of us and request your books, movies, board games, activity kits, literacy kits, or free masks.

She noted they have given away 977 masks so far.

MJCC has formed several committees to discuss the organization of youth forums, recruitment efforts and the potential of a skate park. They have hit the ground running and have created information and a survey and are working with school administrators to share with peers via the school's listserv.

Council Member Bunt noted that all of our local school and UM are back in session.

Council Member Herbert noted the classes are held on different schedules. At the Elementary School, students are there two days and at home learning 3 days. He said the students are really eager to get back to school. The schools are following appropriate safety guidelines and procedures.

Council Member Bunt thanked all of our teachers for tackling this tough job.

Main Street Director Courtney Bennett commented that the fire inspections with local businesses are going well. We sent out a letter to them letting them know about the coming inspections. She said businesses are pleased to see UM students returning to campus. She also reminded everyone about the ribbon cutting at Elite Salon on Saturday at 10 a.m.

Council Member Peterson said there would be no Finance Committee meeting Wednesday.

New Business:

Presentation of Board Handbook – Mayor Cost presented the Council with a draft of the Board Handbook being worked on by Maggie Benson. She said this is an administrative document and is not something the Council needs top formally approve. However, she encouraged them to review it and provide their input.

Approval of Rebuild Alabama Act 2021 Transportation Plan Budget -

The City Clerk explained this budget is required by the State as part of our participation in this program. We receive so little money each year from this tax that we simply let it accumulate to the point we can use it for a match for

some future project. In response to a question from Council Member Herbert, the City Clerk explained this is the second year of the program.

Council Member Herbert then made a motion to approve the budget. Council Member Nix seconded. ALL AYES . . . MOTION APPROVED.



Fiscal Year 2021 City of Montevallo Transportation Plan

In accordance with the Rebuild Alabama Act signed into law March 12, 2019, the City of Montevallo hereby adopts this annual Transportation Plan to use the estimated revenues of \$33,976 in anticipated revenue from the Rebuild Alabama Act (Fuel Bill) fund during the 2021 Fiscal Year as a reserve for matching funds to any state or federal grant funded projects to perform roadway improvements, repairs, resurfacing, reconstruction or maintenance within our existing street/road network during said fiscal year or later years.

Resubmittal of Alabama State Council on the Arts Grant -

Mayor Cost reminded everyone we were not awarded this grant last time. However, they gave us some useful tips for our next application. Therefore, she let the Council know we will resubmit the grant for this coming year. There is no monetary match.

Authorization to submit a grant from the VW Settlement Agreement for a new Bucket Truck – 20% Match required from Sanitation Fund –

As discussed earlier, Mayor Cost reminded everyone this grant requires a 20% match which will come from our Sanitation Fund.

Council Member Herbert asked Mr. Hamby if we need as new bucket truck.

Mr. Hamby said yes, we do. The one we have smokes terribly. As a result, we try not to use it during most of the day. It is critical to our ability to trim tree limbs, as well as hang banners, change traffic lights, and other things.

Council Member Herbert made a motion to authorize the submission of the grant request as described. Council Member Peterson noted the \$29,000 or so in matching funds would come from the Sanitation Account. Council Member Nix seconded the motion. ALL AYES . . . MOTION APPROVED.

Authorization of Mayor to enter into an agreement with American Tower to sell the city cell tower property on Waller St. Proceeds are to be used to payoff our Central State Bank Loans of approximately \$447,000 with the remainder to be held in the Regions Capital Reserve account for future capital uses as approved by the council.

The City Clerk explained this agreement has not completed review by our City Attorney and is not ready for consideration yet.

Old Business:

Ammersee Lakes Paving Request – Tom Bagley

Mr. Burgess informed the Council our bids are nearly ready to go out.

Dailey Park Update -

Mayor Cost informed the Council we met with our project architect, Chuck Kelly, last week. He is looking at the options for play equipment at the park. We have asked residents for their input, as well.

Board Appointments:

Council Member Peterson made a motion to approve the appointment of Stacia Brady to the BZA. Council Member Herbert seconded. ALL AYES . . . MOTION APPROVED.

Other Business:

Reminder of Special City Council Meeting to Canvass the Election Results – Tuesday, September 1, 2020 at 12:00 Noon

Tomorrow – August 25, 2020 - is Election Day. Polls open at 7 am and close at 7 pm. Registered voters in Montevallo vote at the Orr Park Rec Center / Boys & Girls Club

Mayor Cost updated the Council on the progress of the Hwy 25 grant. She said she walked the project area with representatives from ALDOT recently. Matthew Burgess said ALDOT gave us some useful feedback and we have adjusted our project plans accordingly. He feels very good about our chances to get this grant. However, if we don't, we have an opportunity to get funding through the MPO, and he feels we have a very good shot at getting approved there, as well.

Council Member Bunt said she is very excited about this project, and thanked Mr. Burgess for his efforts.


