Chief Davis also mentioned that he would like to discuss with the Public Safety Committee the possibility of building a storm shelter in the city.

Mayor Cost said Chief Davis has done a lot of work on this issue and asked that the committee members work with the City Clerk to schedule a date for the meeting.

Chief Davis said that interest in volunteering with the department has increased lately. As a result, their costs for turnout gear and other equipment has increased accordingly. The new radios are especially costly.

Council Member Herbert informed the Council that the ValloCycle board will meet Thursday at 6:00 p.m. He said one of the new bike racks was installed. Two more are awaiting installation.

The Arbor Board will meet Tuesday, January 28th at 5:30 p.m. at Parnell.

Kirk Hamby, Director of Public Works, informed the Council the Christmas decorations are all down. The new banners will go up soon. With all the rain, his crews will have to start mowing rights-of-way again very soon. They are also working with Ms. Barone to clean-up the Recycling Center.

Olivia Barone, Sustainability Coordinator, said she has enjoyed getting to know our community. At this point, her focus has been on restructuring and improving the Recycling Center. However, she asked to meet with the Sustainability Committee to discuss some other ideas she has for our program.

Shane Baugh, Director of Parks and Recreation, reported that not much has changed since his last report. Basketball is wrapping up and spring registration will be underway soon. This year, we have 65-70 kids signed-up to play soccer. The trails at Shoal Creek Park ar4e open. Some of the low-lying trails are subject to flooding. We may need to consider boardwalks in those areas. We've also improved the landscaping at Stephens Park.

Mayor Cost informed the Council that Ms. Woodham needs the Council's approval to place photos of the Mahler family on the signs at the bridges at Shoal Creek Park.

Council Member Nix reminded everyone that Soup and Bingo will be held again this year at the Senior Center, sometime around Valentine's Day. This is always a good event.

Dwight Dellinger, Manager of the Golf Course, said play continues to increase at the course despite the rain. He said we were up 245 rounds over the previous year. We also have a few new members. The Chamber tournament is scheduled for April 16th. We also have two high school teams using the course for practice. We are receiving as lot of compliments from players regarding the improved condition of the golf course.



Mr. Gilbert also mentioned the upcoming Golf Tournament. In addition, he informed the Council that the Chamber is leaving GLOCO on January 23 because UM needs that space. At this point, he is not sure where they will relocate, and welcomed any suggestions.

Montevallo Main Street Director Courtney Bennett thanked Mr. Hamby and the folks at Public Works for all of their assistance with the holiday decorations. She pointed out that our 2019 Impact Report was picked up by the Shelby County Reporter and there is a very nice article in the paper about us. In addition, the paper has asked her to write a column every now and then about the goings-on in our community. She also informed the Council our new banners for Main Street will be installed soon.

Mayor Cost reviewed the agenda items.

Approval to use Wex Fleet – State of Alabama Fleet Card Program:

Chief Littleton said there are basically only two gas stations in Montevallo which still accept our old Fuelman cards. In addition, it is difficult to find as station which accepts Fuelman cards when we are travelling to conferences or whatever outside of Montevallo. Therefore, he recommends we start using the WEX cards, which are on the State Bid list and recommended by them.

Council Member Nix asked if the employee must key-in their mileage when they use the card.

Chief Littleton said that was correct. They enter their employee number, as well. This helps to keep track of mileage and ensure the cards are not being used improperly.

Ordinance establishing salary of Mayor (2nd reading):

The City Clerk explained that because this is an ordinance the vote at the last meeting was only the first reading. It needs to be voted on again tonight to be approved.

Set Date for Employee Handbook Update Special Work Session:

The Council discussed this and settled on Wednesday, January 22nd, 5:30 p.m. at City Hall. The City Clerk said he would post the notice.

Mayor Cost said we are still working on updating our board appointments.

Under Other Business, Mayor Cost said we need to add approval of the Mahler family photos to be used on the bridge signs. A private citizen is paying for these signs.

Mayor Cost also mentioned a grant for \$50,000 she wants to submit which would allow us to review the fines and fees we charge in Court and elsewhere in an effort to ensure they do not pose an undue hardship or burden on low income individuals. There is no match required.

ORDINANCE NO. 01132020-300

CITY OF MONTEVALLO ORDINANCE ESTABLISHING THE MONTHLY SALARY OF THE MAYOR

AN ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MONTEVALLO, ALABAMA AS FOLLOWS:

Section 1. That the salary of the mayor of the City of Montevallo, Alabama, shall be and the same is hereby fixed at the sum of \$2,000 per month; \$24,000 per annum.

Section 2. This ordinance shall become effective on the first Monday in November 2020 and shall continue in force and effect until repealed by action of the council.

Section 3. The provisions of this ordinance are hereby declared severable; if any portion of this ordinance shall be held unconstitutional or otherwise invalid by a court of competent jurisdiction, such ruling shall not affect the remaining portions of this ordinance.





Council Member Nix made a motion to approve the use of these photos. Council Member Herbert seconded. ALL AYES . . . MOTION APPROVED.

Grant:

Mayor Cost explained that we have been encouraged to apply for a \$50,000 grant (no match required) designed to help us reform local fines and fees which disproportionately and adversely affect low-income people and people of color. If we are selected to participate in this project, Montevallo could serve as a model community for like is across Alabama, and the Nation.

Included below a detailed summary of the project and the steps involved. Once again, there is no cost to us, and any recommendations which result from this study will have to be approved by the council before they can be enacted. We really have nothing to lose. Because the timeframe to submit this application is short, the Mayor asked this be added under Other Business on tonight's agenda. As recommended by Carla Crowder with Appleseed, she said she would serve as the lead elected official and the City Clerk would serve as the senior staff member.

PolicyLink, together with the Fines & Fees Justice Center and the San Francisco Financial Justice Project, is seeking proposals from jurisdictions interested in reforming local fines and fees that disproportionately and adversely affect low-income people and people of color.

Specifically, they are offering \$50K and technical support for an 18-month project that will create a cohort of jurisdictions they hope will "create innovative models of effective reforms and inspire localities across the country to do the same."

Applications can come from teams which must include a jurisdiction-wide elected official and a senior government staff member to serve as point people. Other team members can (and should) include advocacy groups, groups representing impacted populations, policy experts, and data specialists.

I believe Montevallo is ideally positioned to apply for this grant.

I envision Mayor Cost being the jurisdiction-wide elected official to endorse/sign off on the application with the senior government appointee TBD. Note, the funder's expectation is that the senior appointee will be the point person on this project, attending a few convenings, being a consistent presence on conference calls, etc.

Applications are due Feb. 14. Grants will be awarded in March, with the process to begin immediately.

Per the application website, participating jurisdictions commit to:

- 1. Engage community organizations and people directly impacted by fines and fees to build an understanding of the community's most pressing fine and fee concerns and to help identify and implement solutions;
- 2. Conduct an internal assessment to identify fines, fees, tickets, and financial penalties that have an adverse impact on low-income people and people of color;
- 3. Develop a policy agenda informed by the assessment and continued engagement with community members;
- 4. Enact or, have an actionable plan to enact, at least three meaningful fine and fee reforms;
- 5. Demonstrate national leadership by sharing their knowledge and lessons learned with other jurisdictions.

Here is how I envision that looking in Montevallo.

- 1. **Engage directly impacted people to understand pressing concerns and identify and implement solutions:** Appleseed's <u>Under Pressure report</u> is an ideal first step in this process, as it includes data and stories describing how fines and fees burden poor people and people of color across Alabama. Appleseed could work with the city to convene local direct service providers to bring impacted individuals even more closely into the process via community forums and listening events.
- 2. **Conduct an internal assessment:** This portion of the project would require expert technical assistance with data management and analysis. An outside technical expert could work with the city to collect data on fines and fees, with an eye to finding out who owes money (demographic data as well as info about "frequent users" who owe multiple fines I suspect we'd find many people have been repeatedly fined for offenses like driving with a suspended or revoked license or without insurance), how much they owe, and how long they've owed it. Dr. Richard Fording of the University of Alabama has agreed to fill this role.
- 3. **Develop a policy agenda:** I believe Appleseed's policy expertise would be extremely helpful in this portion of the report, but I would also seek to consult with Sharon Brett of the Harvard Criminal Justice Policy Project (CJPP). Sharon wrote the paper on proportionate sanctions that Appleseed at its Oct. 24 event with the Aspen Institute proffered as an answer to the question of how to appropriately sanction poor people. CJPP is unable to commit at this time, but Sharon is committed to consulting on this project as an independent expert.
- 4. **Enact (or have a plan to enact) reforms:** This would be up to the city to do, but of course Appleseed would be available to support and assist as needed. Depending on the nature of the reforms, they might be done via executive action by the mayor or via local ordinance that would require approval by the city council.
- 5. **Demonstrate national leadership:** Again, this would be led by the city, with support from Appleseed and other partners as appropriate.

Next steps:

- 1. Secure agreement from the city and identify a senior appointee to sign on.
- 2. Talk with the funder about how we can best position ourselves to receive this grant.
- 3. Apply. The application does not require a detailed budget. It does require letters of commitment from the elected leader and support from any nonprofits or other listed as team members.

Council Member Herbert said he thought this opportunity was "really cool."

Mayor Cost said she just learned about this initiative last week at a meeting in Montgomery. She is very excited about the possibilities, as well.

Council Member Herbert made a motion to approve the grant application, and team members. Council Member Peterson seconded. Council Member Nix ABSTAINED. ALL OTHERS VOTED AYE . . . MOTION APPROVED.

Citizen Participation:

Tom Reynolds expressed his opposition to the proposed Montevallo Cottages development. He said he would be at the Planning Commission meeting Thursday night.

Bill Owens also expressed his opposition to that development. He said the water pressure in the area is already too low.

Council Member Nix. Who serves on the Water Board, said he would look into the water issue.

There being no further business before the Council, Council Member Nix made a motion to adjourn. Council Member Peterson seconded. ALL AYES . . . MEETING ADJOURNED at 6:11 p.m.
