Mayor Rusty Nix, Council Member David King, Council Member Lelia Mitchell, Council Member Kenneth Dukes, Council Member Sonya Swords. Council Member Martha Eisenberg (Absent). Quorum present.

Work Session called to order at 5:30 p.m. by Mayor Rusty Nix.

Discussion of New Business Items on Agenda

Mayor Rusty Nix called for Committee Reports:

Council Member King called for the Police Department Report. Chief Littleton reported last month department had 90 Total Reports: 17 Traffic Accidents, 145 Traffic Citations, 24 Total Arrests, 2 Burglaries, 0 Auto Theft, 4 Domestic. He read the report from Officer Wilder Code Enforcement inspected 4 Cases from last period and Closed 1 Cases and has 4 Active Cases. The Total Cases for the Year is 90. See Appendix 1.

Council Member King called on Chief Davis for the Fire Department report. Chief Davis reported there were 47 Calls the 2nd half of November and Total Calls for November is 115. There were 33 EMS, 2 Lift Assists, 2 Structure Fire, 0 Brush Fire, 0 Electrical Fire, 0 Vehicle Fires, 2 Fire Alarms, 5 MVC, 2 Assist Other Agency, 0 Assist Public. See Appendix 2.

Council Member King reported Planning and Zoning will meet Thursday, December 16th at 6:00 pm in Council Chambers and is open to the public. The meeting is a Public Hearing.

Mayor Nix called on Council Member Dukes for Sustainability. Council Member Dukes called on Kirk Hamby for Public Works Report. New Brush Truck is on the Road. Vacuum Truck running to get leaves out of gutters and streets. Volume is up in Recycling Center. Questions from Council about where people may be coming from to bring items to our Recycling Center.

Mayor Nix called on Shane Baugh for the Parks and Recreation Report. Shane Baugh, Department Head, Parks and Recreation reported there was a break in at the Mahler House and the only damage was to back door. Youth Sports Basketball is ongoing. High School Gym is closed for floor repairs this Friday through December 31, 2021.

Mayor Nix called on Council Member Mitchell for reports on Education, Arts, and Outreach. Council Member Mitchell called on Savannah Kitchens, Library Director. Savannah Kitchens presented her report for the Parnell Memorial Library. Savannah reported the Food Donation is completed; Letter to Santa is completed; and the Library will be closed December 24 – December 27 for the Christmas Holiday. See Appendix 3.

Council Member Mitchell called on Sarah Hogan, Program Director, Impact Montevallo, Sarah reported SRO's are teaching classes at school; vaping tickets and fines are being issued; the City of Fayette contacted Sarah requesting a meeting with members of MJCC to meet with their Mayor and interest. Blue Ribbon Coalition: The video is completed for the National Leadership Forum in National Harbor, Maryland in January and Impact Montevallo is one of 18 coalitions across the nation that received this recognition. Council Member Mitchell called on Olivia Gilbert, Montevallo Junior City Council (MJCC) Junior Mayor. Olivia reported on the MJCC activities: Toy Drive is completed, and the toys will go to Shelby Emergency Assistance. Olivia reported there will be a retreat for middle school students on how local government works. She asked Council and attendees to consider nominating a young leader in Montevallo for Super Youth Saturday to be featured on their website and social media sites.

Council Member Michell reported Montevallo Schools will be closed December 20 – January 2 for Christmas break. She reported the American Village tours are underway for Christmas. And the Education, Arts, Outreach will meet this week.

Mayor Nix called on Council Member Swords for reports on Finance, Economic Development & Tourism. Council Member Swords called on Courtney Bennett, Executive Director, Montevallo Main Street. Courtney thanked Julie Smitherman for serving five years as Board President of Montevallo's Main Street and advised she would be stepping down. She reported Sarah Hogan would be incoming Board President in January. Courtney announced the winners of the Window Decoration Contests. And reported to Council Arty the Elf is being hidden in town. The finder of Arty receives \$50 in gift cards to local shops and businesses. She announced Main Street is partnering with Impact Montevallo to sell coloring books featuring scenes from downtown Montevallo and can be purchase for \$5 and gave a list of locations where they can purchase the coloring books. Council Member Swords called on Adele Nelson, Executive Director, Montevallo Chamber of Commerce. Adele reported Chamber Chatter was delivered on November 26. The Chamber attended the Center 4 Elder Justice & Advocacy. The Montevallo Christmas Parade was held December 2 and there were 70 entries, the biggest parade yet! The Chamber held a Christmas Open House on December 9 at Main Street Tavern with 100+ attendees. See Appendix 6.

Ms. Sarah Hogan, program director provided the following report:

- Partnerships: Impact has been busy partnering with a variety of local organizations on initiatives and activities that promote positive behavior choices. You'll hear about them tonight from Junior Mayor Gilbert and Courtney, our Executive Director of Montevallo Main Street. We've grateful for the opportunity to work together to truly make the biggest impact in the community as possible.
- SROs: Our SROs have been busy teaching classes and building relationships that are
 encouraging youth to make better decisions. Officer Holloway was just named the
 Staff member of the month at the high school, so congratulations to him. Both he
 and Officer Wilhite are doing an awesome job and I appreciate the work they are
 accomplishing. They do continue to write vaping tickets and we are holding our
 vaping class once a month with good response from parents.
- Fayette: Junior Mayor Gilbert may also mention this in her report, but I have been contacted again by the City of Fayette requesting a meeting with members of MJCC to meet with their Mayor and interested students in their newly established Junior City Council. As you recall, the City of Fayette has used our MJCC as an example to establish their own organization, using MJCC's documents and presentations. They have had a huge interest in the program and appreciate the support and kindness of Montevallo in helping to create this program for their youth.
- Window Clings & Beverage Napkins: Impact Montevallo volunteers will be delivering window clings to local convenience stores to hang on alcohol cooler windows and beverage napkins will be delivered to local restaurants. The message is Consequences Happen! Buying and Serving Minors Alcohol has damaging outcomes for everyone. Decisions Today. Impact Tomorrow.
- Blue Ribbon Coalition: Thanks to Courtney for helping me complete my video today
 for the National Leadership Forum in National Harbor, Maryland in January for the
 Blue Ribbon Coalition Award recognition. Impact Montevallo is one of 18 coalitions
 across the nation that received this recognition.

- Alcohol Home Delivery & Federal Infrastructure Bill: The coalition is staying apprised of the current status and concerns regarding the Alcohol Home Delivery bill that was passed this year. And we are working to ensure our community is aware to ensure alcohol is not delivered and available to minors under the age of 21. IDs must be scanned for delivery. Only wine is direct ship (6 wineries & 1 wine club) Wine, Beer, Liquor can be delivered by a local licensed company (Only 4). Delivery drivers receive bonus for making the right decisions. Prevention specialists across the State are also looking for Opt Out Options. Also, in case you were not aware, one of the positive measures associated with the federal infrastructure bill, in 3 4 years, mandatory impairment regulations will be required in all vehicles.
- Marijuana Opt-In: The State prevention organizations are making a list of Municipalities that will not opt-in for "medical" marijuana dispensaries as we engage other communities across Alabama. Hopefully, by showing strength in numbers this list may encourage other communities to remain out as well. Major Clay Hammac did send a message that he received a verbal commitment from the Shelby County Commission but it may be up to each municipality to confirm. I would ask that you start considering what Montevallo will do regarding medical marijuana dispensaries.
- We are proud of how much we have accomplished this year and feel that we have made an impact and look forward to serving the community even greater in 2022.


