Executive Summary:

The Surveillance Systems in George Daily Park, Orr Park and Shoal Creek Park are currently either operationally unreliable or non-functioning and are not providing the coverage capability required to protect and cover the park facilities as intended. To facilitate monitoring at 3 parks around town, local cameras were installed at each park and connected to a local switch. The local switch at each park is connected via remote cellular connections and tied directly back into the NVR (Network Video Recorder) at City Hall. The current connectivity utilizes an SD-WAN device (Sophos RED) with a 4G module added to it as well as a dedicated cellular plan at each park and a dedicated 4G modem (Cradlepoint) to receive each park's connection back at City Hall. The Sophos firewall used at City Hall requires a yearly Network Protection License to support this functionality and connection.

While the system as described above should provide dependable connectivity, historical evidence implies that, as currently implemented, it does NOT provide consistent and dependable operation, is likely limited in bandwidth and requires all camera footage to go through a very limited and unreliable pipe before even being recorded.

Solution:

CMIT Solutions proposes a solution which provides several advantages over the current system.

Executive Summary

The City of Montevallo currently outsources their IT support to VC3, a company based in different state with no local staff. VC3 attempts to perform most work remotely and utilizes a couple of remote contractors based out of Montgomery, AL when on-site work is required. Their contract expires in August or September 2022 and the City Clerk / Treasurer is looking for competitive quotes from companies that can provide more expedient support (with staff more local to the area) for issues that require on-site work.

The City of Montevallo also has both a security camera system and a separate secure access system (ie. with FOBs to enter building) which they inherited from Shelby County. Shelby County installed and used to maintain both of these systems for the City prior to organizational and budget changes a few years ago. These system are supported on an ad hoc basis by Gorrie-Regan, a company based in Birmingham, AL. As both the security camera system and the secure access system utilize the City of Montevallo's IT system and require IT support to make changes and debug issues, both the City Clerk / Treasurer and the Chief of Police would strongly prefer "One Stop Shopping" and would like the provider of IT services to also support the security camera and secure access systems.

Situation Summary

MAIN CURRENT CHALLENGES:

- · Ability to receive qualified on-site support expediently when required
 - Sometimes you just need someone local to handle an issue
 - Some issues that you can demonstrate in 5 seconds in person can take 4 hours to describe in writing or to try and capture remotely
 - To resolve some issues multiple actions must be taken or tried locally. Without a local resource handy, City Hall or Police Department personnel must spend long hours performing these tasks
- One-stop-shopping / One-throat-to-choke
 - Being able to have issues resolved with a single service call or ticket
 - REGARDLESS of whether they involve the IT system, Security Camera Surveillance System or Security Access System or any combination.
- Ability to stay focused on Montevallo City or Police business
 - Verses spending time on IT, Surveillance or Secure Access system issues
 - WITHOUT requiring City Hall or Police Department staff to spend long periods of time personally installing SW updates, making configuration changes or performing tests to get a resolution.

WHAT HAS BEEN TRIED TO DATE:

When previous county and city organizational and budget changes resulted in Shelby County no longer providing support for Montevallo's IT, Security Camera Surveillance and Secure Access systems a 3-year contract for IT support with a remote vendor whose marketing is tailored toward municipalities was signed. This vendor has demonstrated a limited ability to provide local, on-site support for which it is using contract labor out of Montgomery. A decision to renew or end (and replace) this contract must be decided on by the end of September, 2022.

A separate company in Birmingham is now being used on an ad hoc basis to address some of the issues related to the Security Camera Surveillance System and Secure Access System. This company has also not proven to respond as expediently as desired and requires local City or Police Department staff to be involved to coordinate tasks locally and to bridge the overlap between those products and the IT system (and the company which is being paid to service the IT system).

Currently local City and Police Department staff are being used to bridge the gap in local support from multiple companies able to support all 3 systems: IT Systems, Security Surveillance Camera System and Secure Access System. This is resulting in a loss of staff productivity and more time and money required to resolve many issues. In addition, even more money is being spent as each (multiple) of the same companies not providing that capability already have to be involved and paid for even more of their time.

Making no change will likely continue to result in lower productivity, longer times to resolve issues and higher costs. Having each of these services provided and supported by a single, trusted local partner can potentially improve staff productivity, reduce the time it takes to resolve issues and lower costs.
