Work Session called to order at 5:30 p.m. by Mayor Nix.

# **Mayor Nix called for Committee Reports:**

Council Member King called on Chief Littleton for the Police Department Report. The Total Number of Reports so far for January was 93. Officer Wilder resigned as Code Enforcement Officer and Chief Littleton has been working with the Mayor and City Clerk on a new hire. See Appendix 1.

Council Member King called on Chief Davis for the Fire Department Report and he reported the Total Calls for January were 151. See Appendix 2.

Mayor Nix called on Council Member Dukes for Sustainability. Council Member Dukes called on Kirk Hamby for Public Works Report. Kirk gave an update on the Recycling Center that the volume is up. He also reported the Recycling Center will be closed Saturday, February 19 and February 21 for President's Day. Kirk reported that Arbor Day will be held at the Recycling Center on Saturday, February 26.

Mayor Nix called on Council Member Eisenberg for Recreation, Preservation and Community Development. Council Member Eisenberg called on Shane Baugh, Parks and Recreation Department Head. Shane reported registration is way up for soccer, basketball registration is about the same as last year. Council Member Eisenberg asked about having gates at the parks. Shane advised that having a gate would cause more issues than it would solve plus the resources to open and close the gate each day.

Mayor Nix called on Council Member Mitchell for reports on Education, Arts, and Outreach. Council Member Mitchell called on Savannah Kitchens, Library Director. Savannah Kitchens presented her report for the Parnell Memorial Library via Zoom and provided the Library report in Council Packets. See Appendix 5.

Council Member Mitchell called on Sarah Hogan, Program Director Impact Montevallo. Sarah reported February 15 is School Resource Officer Day and there will be two SRO's in Montevallo Schools. She reported about the CADCA's National Leadership Forum and touched on items she learned to bring back to the Montevallo community. Sarah gave an update on legislation that passed regarding home delivery of alcohol and advised there is a flyer in Council packets. See Appendix 6.

Council Member Mitchell called on Olivia Gilbert, MJCC Junior Mayor for the MJCC report. Olivia reported the Youth Civic Engagement Grant is now open; the MJCC volunteered at the Shelby Humane Society. Refresh Cards are ready and will be distributed Thursday. MJCC is working on an art box. And she reminded everyone of nomination for Super Youth Saturday.

Council Member Mitchell reported no school for students at Montevallo Schools will on Monday, February 22. UofM will have a Weather Preparedness Event featuring James Spann on Monday, February 28. UofM College Night and Homecoming will be February 15 – 19. Mid-terms will be February 28. The American Village is open, and they will host the 6<sup>th</sup> annual Festival of Tulips soon. Boys and Girls Club recognizes student of the month.

Council Member Swords called on Adele Nelson, Executive Director, Montevallo Chamber of Commerce. Adele reported a ribbon cutting was held for Sunrise Doughnuts on Saturday, February 5. The Montevallo COC and the Shelby Chamber co-hosted the annual Shelby County Montgomery Drive-In conference. The Strand Coffeehouse held its ribbon cutting on Saturday February 12. The Chamber Luncheon will be February 16 and will feature Melanie Poole, topic is "American Village Festival of Tulips." See Appendix 7.

Mayor Nix called on Council Member Swords for reports on Finance, Economic Development & Tourism. Council Member Swords reported that MDCD met today in Council Chambers.

Council Member Swords called on Courtney Bennett, Executive Director, Montevallo Main Street. Courtney reported Montevallo will host Main Street Alabama's Quarterly Training on March 8 and an additional workshop the day before for Main Street Directors only which will focus on small-scale manufacturing and how the community can support those entrepreneurs and the workshop and will bring up to 125 people from all over the State of Alabama. Montevallo earns the Tree City USA recognition for their commitment to urban forestry

LINCOLN, Nebraska (1/12/2022 10:16:06 AM) – Montevallo was named a 2021 Tree City USA by the Arbor Day Foundation to honor its commitment to effective urban forest management.

Montevallo achieved Tree City USA recognition by meeting the program's four requirements: forming a tree board or department, creating a tree-care ordinance, having an annual community forestry budget of at least \$2 per capita, and an Arbor Day observance and proclamation. The Tree City USA program is sponsored by the Arbor Day Foundation, in partnership with the U.S. Forest Service and the National Association of State Foresters.

"Tree City USA communities benefit from the positive effects that an urban tree canopy has year after year," said Dan Lambe, president of the Arbor Day Foundation. "The trees being planted and cared for by Montevallo ensure that generations to come will enjoy a better quality of life. Additionally, participation in this program helps cultivate a sense of stewardship and pride for the trees the community plants and cares for."

Planting trees in an urban space comes with a myriad of <u>benefits</u> past the recognition of this program. # City Council Meeting February 14, 2022

Ms. Sarah Hogan, program director provided the following report:

- SRQ Appreciation Day: Governor Kay Ivey declared tomorrow, February 15, as School Resource Officer Appreciation Day. In a national proclamation on NASRO's website, the organization cites SROs for bridging gaps between youth and law enforcement and embracing a triad concept of school policing, serving in informal counseling, education and law enforcement roles to support the students and communities they serve. It also describes SROs as "valuable and essential members of the education community" who "deserve unwavering respect and support from the public in the pursuit of keeping schools and students safe." I believe this appropriately describes our SROs. Officer Holloway and Wilhite do an outstanding job of building relationships with students and our community to not only ensure the safety of our campuses but to aid in helping our students build skills for a better future. I thank Chief Littleton for his support of this program. We have seen a tremendous response to having two SROs over the last two years and I hope we can sustain this initiative to give our students and community the best possible service and resources. I will be at the High School tomorrow, to provide students an opportunity to showcase what their SRO means to them during lunch, thank you to the continued support of Principal Bromley. Watch our social media to be a part of the fun. Please join me in thanking Officer Holloway & Wilhite for a job well done.
- CADCA, National Leadership Forum: I enjoyed attending CADCA's National Leadership Forum and receiving our Blue-Ribbon Coalition Recognition in National Harbor, Maryland week before last. Over 2100 prevention specialists and 400 youth from all over the country came together, all fully vaccinated and masked to learn best strategies and practices. Today, CADCA released a digital form of the conference to gain even more information from all sessions of the conference. I did want to share with you a few bits of information I gained:
  - According to the DEA: Prevention is Key! Drug lord distributors can be taken down, but as long as users still exist and money is on the table, someone else will always step up. We must stop use to stop the drug distribution; we must take the money off the table.
  - Every \$1 invested in prevention saves communities between \$2-\$20
  - DEA seized 20 million counterfeit pills in 2021, does not include other LEAs: often containing fentanyl and are more lethal than ever before.
  - We discussed the difference and risks associated with Delta 8 Cannabis vs. Delta 9
     Cannabis. Delta 8 is being sold here in Montevallo legally and our youth are consuming it via vapes, candies, etc. The drug is allowed due to loopholes in the law

- but should show up on a drug test as THC and is 50/75% as psychoactive as the illegal form.
- Alcohol deaths increased from 2% to 26% in 2020. 95,000 people die annually from effects of alcohol with 2/3 of the US population are alcohol drinkers
- Almost 6% of newly diagnosed cancer is attributed to alcohol.
- Alcohol Action Network: Just starting in Alabama and we have a meeting next week to discuss how we can better observe and collect compliance data.
- I did have an opportunity to ask Director of the National Institute of Health, division
  of Alcohol Abuse and Alcoholism, Dr. Koob, if he had any words of wisdom about
  Alabama's recently passed Alcohol Home Delivery Bill. He was amazed at the amount
  of alcohol allowed and that we should partner with researchers immediately,
  however, the data gathered will not be sufficient for years to come to change any
  outcomes.
- Virtual Parent Training: Impact along with other DFC organizations throughout the State
  have teamed up to host a virtual parent meeting at the alcohol home delivery bill with a
  presentation by Summer Childers from the Alabama ABC Board on Tuesday, February 22 from
  Noon-1:00 pm. I have provided each of you with the flyer and placed some out front. The
  information can also be seen and shared via our social media. Please join us and share with
  your peers and colleagues.
- **DFC Grant Updates:** The coalition also continues to work on reviewing and adjusting our yearly action plan. We have received our Notice of Award for Year 3 with an approved budget as submitted. We had a great meeting last week with many new faces and we continue to reach out to as many citizens and partners as possible. We are updating our 12 sector representatives, as required by the grant and I ask that if you are interested in serving in the role designated for the State/Local Government and make a commitment to serve on the coalition, I invite you to do so. Please just let me know of your interest. Of course, I invite all of you to participate as often as your calendar permits.



# **Updates**

- Montevallo will host Main Street Alabama's Quarterly Training on Tuesday, March 8 at First Baptist Church. An additional workshop for Main Street Directors only will be held the day before at Parnell Library. This training, which focuses on small-scale manufacturing and how communities can support entrepreneurs who make a physical product, will bring up to 125 people from all over the state of Alabama. Representatives from all 29 Designated Main Street Communities will be present, as well as some who are located in one of the 43 Network Communities. This is an incredible chance for us to show off our community. Main Streeters love to shop, so our businesses will benefit from this as well. If you are interested in attending the training on March 8 from 10 AM to 4 PM, please let me know and I will send you more information. Registration will launch this week. p
- I'd also like to remind you that, as you make decisions about ARPA funding, Main Street would still like to be considered for a contribution. During the City Council meeting on July 12, 2021, then-Board President Julie Smitherman read a letter into the record during Citizen Participation that provided more details of our request.
  - At that time, we requested that the Mayor and Council earmark \$150,000 from ARPA funds for our non-profit organization to directly assist our downtown businesses through offering Façade Improvement Grants and similar initiatives that support our local business owners, increase property values and tourism in our downtown, increase sales tax revenue, boost our citizens' quality of life, and attract residents and visitors to Main Street. We would spend this money over a period of 3 years. As you know, Economic Development and Community Development is a recommended use for these funds.
  - Although we initially requested \$150,000, we understand that the City has many needs and we would be happy with a smaller amount. To support our highly successful Façade Improvement Grant program, we would like to request at least \$45,000, which would be spent over 3 years. We have already conducted 3 rounds of projects which have impacted a total of 19 buildings and resulted in \$99,334 in private investment downtown, and we spend an average of \$15,000 per year in grant funds. Thank you for your consideration.


