Present: Mayor Rusty Nix, Council Member David King, Council Member Lelia Mitchell, Council Member Kenneth Dukes, Council Member Sonya Swords, Council Member Martha Eisenberg. Quorum present.

Work Session called to order at 5:30 p.m. by Mayor Nix.

#### Discussion of New Business Items on Agenda:

Recommendation accept the bid from CMIT Solutions for the replacement and configuration of surveillance cameras at Parnell Memorial Library, in the amount of \$8,959.90. Funding from Regions Capital Reserve Account.

Recommendation to accept the bid from C & W Concrete in the amount the amount of \$20,00.00 for repairs and improvements to the storm drains along Valley Street behind Montevallo Highschool (ARPA Funds) Storm Water Mitigation.

Adoption of Resolution 08082022-440 to allow the Mayor to negotiate and enter into a contract agreement with BFI Waste Services, LLC, dba: Republic Services of Birmingham, for the purpose of providing Residential Solid Waste Collection.

Montevallo City Council Meeting July 25, 2022 6:00 p.m. at City Hall

Pledge of Allegiance

Present: Mayor Rusty Nix, Council Member David King, Council Member Lelia Mitchell, Council Member Kenneth Dukes, Council Member Sonya Swords, Council Member Martha Eisenberg. Quorum present.

Council Meeting called to order at 6 p.m. by Mayor Rusty Nix. All Council Members present.

**Approval and or corrections of the Minutes** 7.25.22 – Motion by Council Member Mitchell, second by Council Member Eisenberg, All Ayes, Motion passed.

Mayor Nix called on Dewayne Moore - Dewayne Moore Foundation, LLC to address questions from City Council Members. He addressed Council and questions that were asked regarding his organization's experience in developing similar programs and facilities.

#### **Recognitions / Awards:**

#### Opportunities for Citizens to speak to the Council:

Bobby C.P. Pierson 1131 Oak Street – Request to Council/ Historical Preservation Commission regarding having a street named after Dr. Martin Luther King, Jr. and cited several cities that already have done that. Council Member Swords advised Mr. Pierson he could attend the Historical Preservation Commission Meeting on Tuesday, August 9 in Council Chambers for consideration.

#### **Mayor Nix Called for Committee Reports to Continue:**

Council Member King called on Chief Davis for the Fire Department Report. Chief Davis reported there were 127 Reports in July and 911 Total Reports Year to Date. Council Member King asked Chief Davis to talk about Explorers Program and Chief Davis advised Youth ages 14 – 18 year old volunteer each weekend learning skills to become a Fire Fighter. See Appendix 2.

Council Member King reported Planning and Zoning would meet next Thursday, August 18 in Council Chambers and is open to the public.

Mayor Nix called on Council Member Dukes for the Sustainability Report. Council Member Dukes reported Kirk Hamby, Head of Public Works is on vacation but did share with Council Member Dukes there is a list of drainage issues, and they are being addressed it just takes time to get to them all.

Council Member Dukes reported the Historical Preservation Commission will meet tomorrow in Council Chambers at 6 pm and is open to the public.

Mayor Nix called on Council Member Eisenberg for Recreation, Preservation and Community Development. Council Member Eisenberg called on Shane Baugh, Head of Parks and Recreation. Shane gave an update on Stephens Park bathroom: waiting on doors before plumbing fixtures, etc. get installed for safety measures and the goal is to have completed by mid-September before the first big softball tournament on September 11. Shane reported he had looked into a community/ recreation center and reported you have to have community base support like Dewayne Moore said. There used to be an LLC which has since been dissolved and Dewayne was involved with that financially and in meetings.

Mayor Nix called for Education, Arts, and Outreach. Council Member Mitchell called on Savannah Kitchens Parnell Memorial Library. Savannah reported the Library has been participating in the Farmer's Market each week; Mini Music is still ongoing; celebrating "Back to School" with Popsicle Day; Craft Kit of the Month will be ready mid-August; Senior Movie Night in the theater. Council Member Eisenberg questioned how our Library is doing compared to other libraries in the area. Savannah advised the statistics are very different from city to city using a different matrix, per capita, etc. but that she would check and see if the information could be compiled by asking other libraries to share their statistics with her. Council Member King asked about Wi-Fi hot spots and would like the City to consider purchasing more for citizens to utilize. See Appendix 3.

Council Member Mitchell advised Sarah Hogan; Program Director Impact Montevallo is participating in Montevallo's Farmers' Market – this is National Farmers' Market week. No report submitted.

Council Member Mitchell called on Julia Smith, MJCC Junior Mayor. Julia reported the MJCC held its first Board meeting will be on August 15; they welcomed seven new members on August 1; MJCC will be participating at the Tinglewood Festival.

Council Member Mitchell called on Emily Gill to address the Council about ArtWalk. Emily advised ArtWalk is scheduled for October 29 with a rain date of November 5. She requested the Business License be waived for this event. Mayor Nix advised this would be taken up in Other Business.

Council Member Mitchell reported schools start this week: Shelby County Schools will startup Thursday with names that begin with A – J and Friday K – Z. August 15 all students will start school; Council Member Mitchell reported the University of Montevallo (UofM) all Fall classes begin August 22; Council Member Mitchell reported the Boys and Girls Club have increased number from 45 in 2021 to 64 in 2022 and Josh Weeks provided a report in Council packets. See Appendix 4.

Council Member Mitchell reported there would be an Education, Arts, and Outreach Meeting on August 23 from 5:30 pm – 6:30 pm in Council Chambers and there would be a Sister City Commission following beginning at 6:30 pm – 7:30 pm.

Mayor Nix called for Council Member Swords for Finance, Economic Development & Tourism. Council Member Swords reported Adele Nelson, Executive Director, Montevallo Chamber of Commerce is at Montevallo Farmers' Market and a submitted a report that is in Council Packets. Mark your calendars for Saturday, September 10 for the 4<sup>th</sup> Annual Tinglewood Festival and 20<sup>th</sup> Annual Cars by the Creek. See Appendix 5.

Council Member Swords reported Courtney Bennett, Executive Director, Montevallo Main Street is participating in Montevallo's Farmers' Market – this is National Farmers' Market week. There is a report submitted that is in Council packets. See Appendix 6.

Council Member Swords reported Montevallo Development Cooperative District (MDCD) met today, and she was voted as Board Chair. Council Member Swords gave an update on the various projects MDCD is working on: Highway 25 sidewalk project – Mayor Nix signed traffic signal agreement and it has

been sent to ALDOT; Trey Gauntt, Shelby County reported Shelby County is in preliminary stages of converting golf course into mountain bike course and that the golf course grass has been cut; Sims project, concrete is going on and still a few months away from being completed; Stephens Park has already been discussed by Shane Baugh (this is an MDCD project); walking trails at Orr Park has received a bid for the areas of the trails that had been worn away from rain, flooding and tree undergrowth and the quote is for \$45,000. There is excess funds that could be used to repair the walking trails at Orr Park. Council Member King asked if this would be to repair damaged sections of the walking track and Council Member Swords advised because of the dollar amount the project does not have to be bid out but also reported since the roads to get in are so narrow small machinery is needed to access and repair. Mayor Nix advised this could be taken up under Other Business.

**Education, Arts & Outreach** (Schools, Library, UM, Boys & Girls Club, American Village, Sister City Commission, Artwalk, IMPACT) – Reported during City Council Meeting.

**Finance, Economic Development & Tourism** (Finance, MDCD, IDB, Chamber, Main Street) – Reported during City Council Meeting.

**Project Learn** – Members regularly take time to select a book from our bookshelf and read after they eat.


**Healthy Habits** – Groups members were taught to create healthy, convenient snacks.







A Resolution authorizing The Mayor to enter into a Contract Agreement with BFI Waste Services, LLC, dba: Republic Services of Birmingham, for the purpose of providing Residential Solid Waste Collection

WHEREAS, The City of Montevallo seeks to continue to provide and maintain Residential Solid Waste Collection Service to the Citizens of Montevallo and,

WHEREAS, the City of Montevallo recognizes that it is wise and desirable that adequate provision be made for regular and efficient collection of garbage and domestic rubbish (as defined in Solid Waste Act. No 771 as enacted into law by the 1969 Legislature, and as amended, and termed refuse in the Shelby County Board of Health regulations governing the collection, storage, transferring and disposing of solid waste) in certain areas within the jurisdiction of the City in order that the health of the citizens of the City be protected and the general welfare of the City be advanced; and

WHEREAS, the Contractor hereby applies to the City for a franchise in the exclusive residential collection and transportation to a disposal facility of such refuse, garbage, and domestic rubbish within the corporate limits of Montevallo; and

WHEREAS, the City hereby grants this requested franchise under the authority of the statutes of the State of Alabama, Solid Waste Act No. 771 as enacted into law by the 1969 Legislature, and as amended; and

WHEREAS, after soliciting sealed bids in the manner prescribed by Sections 41-16-50 thru 41-16-63 Code of Alabama 1975, and opening received bids in an open public meeting; and,

WHEREAS, BFI Waste Services, LLC, dba: Republic Services of Birmingham was the lowest responsible bidder; and,

WHEREAS, BFI Waste Services, LLC, dba: Republic Services of Birmingham as the lowest responsible bidder provided the requested required documentation to the office of the City Clerk,

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MONTEVALLO, ALABAMA AS FOLLOWS:

Section 1. That the Council hereby authorizes and directs Mayor Rusty Nix to negotiate and execute the necessary documents to effect an agreement between the City of Montevallo and BFI Waste Services, LLC, dba: Republic Services of Birmingham for the purpose of providing Residential Solid Waste Collection Services to the Citizens of Montevallo.
