Montevallo City Council Work Session

April 8, 2024

5:30 p.m. at City Hall

Present: Mayor Rusty Nix, Council Member David King, Council Member Kenneth Dukes, Council Member Martha Eisenberg, Council Member Sonya Swords. Absent: Council Member Lelia Mitchell. Quorum present.

Work Session called to order at 5:30 p.m. by Mayor Nix with Quorum present.

Mayor Nix called for Discussion of New Business Items on Agenda:

- Discussion of Memorandum of Understanding (MOU) with Impact Montevallo effective April 8, 2024; Sarah Hogan, Director, addressed questions from City Council regarding the Drug-Free Communities (DFC) Grant Funding and the MOU.
- Discussion of request to close Island Street from North Boundary Street to Park Drive for Spring Fling Family Food Truck Fest event on April 27th.
- Discussion of request to waive vendor and business license fees for Spring Fling Family Food Truck Fest event on April 27th.
- Discussion of request to declare surplus items to be sold at Public Auction: Walk Behind Reel Mower and Bush Hog Zero Turn Mower.

Mayor Nix Called for Committee Reports:

Council Member King called on Chief Littleton. Chief Littleton read the report for the Police Department; there were 89 Total Reports for the Month of March. See Appendix 1.

Council Member King called on Chief Davis for the Fire Department Report. Chief Davis reported there were 132 Calls for the month of March. See Appendix 2.

Mayor Nix called on Council Member Dukes for the Sustainability Report. Council Member Dukes called on Kirk Hamby, Head of Public Works, reported "The Big Event" was held by the University of Montevallo last Saturday and the Public Works Department is picking up lots of brush; he reported Free Dump Day was held on Saturday, March 30th and the Public Works Department logged 86 man hours, hauled 18 tons to the Shelby County Landfill.

Mayor Nix called on Council Member Eisenberg for Recreation, Preservation and Community Development Reports. Council Member Eisenberg called on Shane Baugh, Parks and Recreation Director. Shane reported soccer season is underway; travel tournaments will begin next week; Easter Egg Hunt had approximately 300 children participate in the event, and everyone had a good time.

Mayor Nix called for the Education, Arts and Outreach Committee Reports. Mayor Nix called on Marissa Wilson Director of Parnell Memorial Library. Marissa reported March was the library's biggest month ever; there were 4,110 visits to the building; 3,263 wi-fi/ computer sessions; 1,255 program participation and 82 community meetings. See Appendix 3.

Mayor Nix called on Miguel Moreno, Council Member of the Montevallo Junior City Council (MJCC). Miguel reported the MJCC sold sno-cones at the Easter Egg Hunt and raised \$238, and they would be participating in the Spring Fling Family Food Fest on April 27th selling sno-cones.

Mayor Nix asked for Committee Reports to Continue:

Mayor Nix called on Sarah Hogan, Director of Impact Montevallo. Sarah discussed the Drug-Free Communities (DFC) Grant funding process in more detail; Sarah shared results from the PRIDE Survey data from years 2019 – 2024; there has been a great decrease in 30-day usage by our youth – Alcohol usage has decreased from 25% to 6%; Marijuana usage dropped from 19.7% to 1.5%; Cigarette usage dropped from 15.2% to 0%; Prescription Drug usage dropped from 14.3% to .8% - the positive work and opportunities provided through the DRC Support Grant for our coalition has made an impact in our community. See Appendix 5.

Mayor Nix called on Council Member Swords for Finance, Economic Development & Tourism. Council Member Swords called on Courtney Bennett, Executive Director of Montevallo Main Street. Courtney reported The Type Shop complete their Façade Grant project last Friday; new program, K.A.S.H. Market, an initiative to support youth entrepreneurship (in partnership with Impact Montevallo, Montevallo Chamber and Parnell Library); Courtney invited everyone to attend Dr. Caplow's Environmental Studies Capstone Course on Friday, April 19th at 9 AM in Council Chambers as students present their projects: ValloCycle and Glass Recycling. See Appendix 6.

Council Member Swords called on Adele Nelson, Executive Director Montevallo Chamber of Commerce. Adele reported the Onion Sale deadline is April 16th; April Chamber Luncheon features Main Street Alabama President and State Coordinator; Montevallo Golf Tournament will be held April 18th; the Chamber is co-hosting Shelby County Small Business Awards on May 22nd. 

2024 National Child Abuse Prevention Month Montevallo, Alabama

WHEREAS, children are our nation's most vulnerable members as well as our nation's most valuable resources, helping to shape the future of Alabama; and

WHEREAS, positive childhood experiences (PCEs) - like loving caregivers and safe, stable, and nurturing relationships - can help mitigate trauma and the negative impact of adverse childhood experiences (ACEs) to promote the social, emotional, and developmental well-being of children; and

WHEREAS, childhood trauma can have long-term psychological, emotional, and physical effects throughout an individual's lifetime and impact future generations of their family; and

WHEREAS, childhood trauma, including abuse and neglect, is a serious problem affecting every community in the U.S., and finding solutions requires input and action from everyone; and

WHEREAS, children who live in families with access to concrete economic and social supports are less likely to experience abuse and neglect; and

WHEREAS, prevention is possible because of the partnerships created between families, prevention advocates, child welfare professionals, education, health, community, and faith-based organizations, businesses, law enforcement agencies, and local, state, and national governments; and

WHEREAS, we acknowledge that in order to solve the public health issue of abuse and neglect we must work together to change hearts and mindsets through storytelling and sharing, center the needs of families, break down bias and barriers, and inspire action from expected and unexpected partners in prevention; and

WHEREAS, we are committed to advancing equitable, responsive, and effective systems that ensure all children and families are healthy and thriving; and

WHEREAS, we recognize the need to prioritize kids and invest in more prevention initiatives like home visiting and family-strengthening policies, economic supports, and community-based child abuse prevention programs at the national, state, and local levels; and

NOW, THEREFORE, I, Rusty Nix, as Mayor of the City of Montevallo, do hereby proclaim April as NATIONAL CHILD ABUSE PREVENTION MONTH in Montevallo, Alabama, and urge all citizens to recognize this month by building a narrative of hope for children and families through collaboration and the creation of an ecosystem of primary prevention that does not currently exist in this country.

City Council Meeting: April 8, 2024

Ms. Sarah Hogan, program director provided the following report:

- ✦ **Grant Application:** We are in the process of compiling our grant application materials for the competing DFC 6 – 10-year grant award. The Application is due next week, and award notices will be received in September. In the process of reviewing and gathering data for the application – I wanted to share some amazing news.
 - According to PRIDE Survey data, 2019 – 2024, we have seen a great decrease in 30-day usage by our youth.
 - **Alcohol:** We’ve gone from 25% usage to 6% usage. – that is a 19% decrease.
 - **Marijuana:** We’ve gone from 19.7% usage to 1.5% usage. – that is a 18.2% decrease.
 - **Cigarettes:** We’ve gone from 15.2% usage to 0% usage. – that is a 15.2% decrease.
 - **Prescription Drugs:** We’ve gone from 14.3% usage to .8% usage. – that is a 13.5% decrease.
 - The positive work and opportunities provided through the Drug-Free Communities Support Grant for our coalition has made an impact in our community.
- ✦ **End Addiction Walk:** This past weekend, we showcased our SPOT Trailer at the End Addiction Walk in Birmingham. We had over 100 people visit our booth and trailer. We had a lot of great feedback and two organizations, the Addiction Prevention Coalition and Girls, Inc. both have requested a training session with the trailer for their entire staff. We are grateful to have this tool to help educate and encourage important conversations that will aid in keeping our youth substance free. It is also a great way to showcase the great things happening in Montevallo. Thank you to Officer Holloway and Jennifer Toliver for assisting me during the event. Our partnership with the Police Department is vital and greatly appreciated.
- ✦ **Alabama SAYS Conference:** Tomorrow I will be attending the Annual Alabama SAYS, Substance Abuse Youth Summit, Conference in Montgomery. The conference brings together decision-makers and service providers across Alabama to forge partnerships and develop strategies that will better protect Alabama’s youth. The Alabama Substance Abuse Youth Summit is made possible by a grant from the National Alcohol Beverage Control Association. I look forward to bringing back valuable information to coalition members to create strategies for Montevallo’s youth.
- ✦ **KASH Market:** Do you know any youth that have an entrepreneurial mindset? The K.A.S.H. (Kids' Action Side Hustle) Market is a new initiative that will give young

makers, crafters, designers, and entrepreneurs an opportunity sell their creations. Offered to youth ages 5-18.

Memorandum of Understanding

This agreement between the Impact Montevallo and The City of Montevallo shall be from April 8, 2024 until terminated by mutual agreement:

RESPONSIBILITIES OF THE COALITION:

- a. Set policy for and oversee its own programs including goals and objectives in alignment with the DFC Support Program’s Terms and Conditions.
- b. Participate, advise, and/or direct staff and volunteers, set goals and objectives for contract employees, and negotiate and make recommendations for contracts in collaboration with the grant recipient/legal applicant.
- c. Create, approve, and partner in the management of the DFC budget in compliance with grant requirements.
- d. Provide copies of all required documents to the grant recipient/legal applicant as requested.
- e. Reimburse grant recipient/legal applicant for any indirect or direct expenses incurred by the coalition with prior approval.
- f. Be solely responsible for liabilities arising out of its program and its interaction with program participants.

RESPONSIBILITIES OF THE LEGAL APPLICANT/GRANT RECIPIENT:

- a. Provide the coalition staff with office space and storage space.
- b. Compile financial reports on a mutually agreed upon schedule and provide to coalition.
- c. Provide accounting services to prepare and distribute payroll, pay invoices, prepare and submit the appropriate forms for employment, wages and payroll taxes on behalf of the coalition.
- d. Negotiate and/or bid and approve contracts in collaboration with the coalition.
- e. Maintain all records pertaining to costs and expenses to reflect costs of labor, materials, equipment, supplies, services, and other costs and expenses when reimbursement is claimed or payment is made and share such information with the coalition.
- f. Obtain Workman’s Compensation Insurance and liability coverage for the coalition’s employee.

Impact Montevallo and The City of Montevallo agree to abide by all applicable federal and state anti-discrimination statutes, regulations, policies, and procedures. This agreement shall be subject to all applicable provisions of state and federal law and regulations related to the delivery and funding of grant activities.
