
Jean Home Helping Care – Conditional Use

This is a request from Marietta Fields Chappell, Jean Home Helping Care, LLC, property owner, for the approval of a conditional use to allow for the development of a Group Care Home, as listed in Article 11.02 B of the *City of Montevallo Zoning Regulations*. The subject property is zoned R-2 Single-Family Dwelling District and located at 120 Peach Street (77 Peach Street) in the Aldrich community. (Parcel ID 58-27-4-19-4-007-001.003)

DISCUSSION

i.

The subject property is located in the Aldrich community, west of downtown Montevallo and south of Highway 204 along Peach Street. It is approximately 1.63 acres of moderately wooded land and contains a single-family residential home. Peach Street currently terminates at the driveway of the existing home. The surrounding area includes other single-family residential homes of traditional construction and mobile homes.



PROPOSED DEVELOPMENT

The applicant has submitted a request to establish a group home to provide comprehensive care and support for individuals living with disabilities. A group home is a conditional use in the R-2 District and requires review by the Planning and Zoning Commission and City Council.

A business proposal provided by the applicant is included at the end of this report. The proposal indicates that Jean Home Helping Care was established in 2022 with a vision to "empower individuals with disabilities to fulfilling lives and achieve their personal goals in a nurturing environment." Core values are identified as compassion, inclusivity, empowerment, and respect for individual dignity.

A 2024 market analysis by the Centers for Disease Control provided by the applicant indicates that one in three Alabama adults live with a disability leading to many current facilities at capacity. According to the applicant, as demand for group homes increases, the challenge to find safe, and reliable care options also rises.

The proposed facility would provide 24-hour, seven days a week residential care in a home-like environment for individuals with mental and physical disabilities. Proposed services include assistance with daily activities such as bathing, dressing, and medication management. Included programs will involve partnering with local healthcare providers for regular health and wellness checks, and nutritional counselling including specially prepared meals. Recreation is also incorporated into programs including organized social events, outings, and creative workshops, engaging with local organizations when possible.


The facility will initially house five residents with plans for future expansion. Room arrangements include two private rooms and two semi-private rooms. Staffing for the facility is proposed with six full-time and three to four part-time staff members:

Full-Time Positions	Part-Time Positions

The facility is intended to be privately funded and the applicant would also look to apply for grants, government funding, and community donations for future support. Future growth plans include adding four to five additional private and semi-private rooms within two years of startup.

COMPREHENSIVE PLAN

The Montevallo Comprehensive Plan, identifies the subject property as part of the "Rural Residential" land classification. The Rural Residential land use classification is primarily characterized by large estate style lots with primary uses including singlefamily detached homes, parks, schools, and places of worship. Privacy over convenience is often emphasized in this district.



The proposed care facility emphasizes residential care in a home-like environment. One of the goals of the proposed use is to help individuals feel like part of their community in an integrated setting as opposed to a more clinical facility isolated from the community.

Two letters of support have also been included with this report that were provided by the applicant with their application.

ADDITIONAL APPROVALS REQUIRED

The Montevallo Fire Chief, Water and Sewer Board and the City Engineer have reviewed the conditional use request. Water is available to the site. Sewer service is also available with a service line along Highway 204 but is currently not connected. The Water and Sewer Board inquired if sewer would be connected for this development.

The Planning and Zoning Commission makes a recommendation to the City Council regarding the conditional use request. Conditional uses require consideration of the surrounding area for appropriateness in its application. In consideration of a conditional use, the Planning and Zoning Commission may impose conditions and restrictions upon the property; however, further conditions may be imposed to reduce or minimize any potentially injurious effect of such conditional use upon other properties in the neighborhood, and to carry out the general purpose, and intent of these regulations.

In approving any conditional use, the Planning and Zoning Commission may specify the period of time for which such approval is valid for the commencement of the proposed conditional use. Pursuant to a conditional use approval by the City Council, the applicant will be required to apply for appropriate permits to modify the building for multiple occupancy as a care facility.

SUMMARY

A conditional use may be approved by the City Council only upon determination that the application and evidence presented clearly indicate that all of the following standards have been met:

- The proposed use shall be in harmony with the general purpose, goals, objectives and standards of the City of Montevallo Comprehensive Plan, these regulations, or any other official plan, program, map or regulation of City of Montevallo;
- The proposed use shall be consistent with the community welfare and not detract from the public's convenience at the specific location;
- The proposed use shall not unduly decrease the value of neighboring property; and
- The use shall be compatible with the surrounding area and not impose an excessive burden or have a substantial negative impact on surrounding or adjacent uses or on community facilities or services.




