Work Session Called to Order at 5:30 P.M. by Mayor Nix with Quorum present.

Mayor Nix Called for Committee Reports:

Mayor Nix called for the Public Health and Safety Reports. Council Member David King called on Chief Burr for the Police Department report. Chief Burr reported there were 75 Reports for the month of October and 892 Total Reports for the Year. Chief Burr reported on the partnerships and community outreach the Montevallo Police Department had been involved in over the past month. See Appendix 1.

I want to inform the community that ICE has been actively taking people in Montevallo and Calera. This past Tuesday, October 21st, around 8:45am, three ICE agents detained a community member in downtown Montevallo, near the corner of Morgan and Middle Streets, just a few blocks from City Hall.

The agents pulled over a Nissan SUV with several occupants, and were pressuring a young Hispanic woman to exit the vehicle. The agent was recorded on video saying the following:

"I don't want to hear from you, OK? You're not in control of the vehicle, so sit there and shut up. You know what? You're the one being rude. We're trying to do our job in a safe manner, so the door needs to get opened now. We're past being nice at this point. The door needs to be opened now. He's going back to get the tool, and we're going to break the window."

Despite repeated requests, the ICE agents would not produce a warrant, or explain the reason for their actions. The agents were white males, wearing vests marked with "DEA," "ERO," and "FBI." They arrived in two unmarked vehicles: a black Jeep Grand Cherokee, Alabama License Plate 2749BD4, and a gray Dodge Ram 1500 Pickup, Alabama License Plate 6698AW6.

If anyone hearing this sees these vehicles, or observes other suspected ICE activity, I ask that you contact the Birmingham Migra Watch Hotline: 1-888-664-2325 You can also reach them via Facebook and Instagram. They provide verified information on ICE activity to the public.

All of this information I've given is available as a video on the Birmingham Migra Watch page.

I have a handout here, in English and Spanish, that explains how you can report ICE sightings. I also have cards and flyers that explain what your rights are when confronted by them, in English and Spanish.

In the video, two Montevallo Police cruisers are shown at the scene, blocking the street with their vehicles and observing the incident.

Given the overreach of the Federal government in weaponizing ICE enforcement, I'm asking the Mayor, Council, Police Chief, and municipal employees to not voluntarily provide any information or assistance to ICE.

I'll be available after tonight's meeting if anyone has any questions. I can get you in touch with people that can help. We don't need ICE abducting people in our community.


