A Resolution authorizing The City to apply for a Community Development Block Grant via Shelby County for the purpose of remodeling the James D. Seaman Scout Lodge

WHEREAS, The James D. Seaman Scout Lodge was constructed in 1995 and has served the community's scouting program, as well as, provided for community meeting space and,

WHEREAS, the City of Montevallo wishes to remodel and renovate the existing structure to continue to provide a facility for the scouting program and to offer community meeting space for youth and,

WHEREAS, the facility will be updated to offer an after school activity area for community youth.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MONTEVALLO, ALABAMA AS FOLLOWS:

Section 1. That the Council hereby authorizes the application for a Community Development Block Grant in the amount of \$ 102,273.16.
