Section 3. That Mayor Rusty Nix is authorized to sign and enter the application for said grant on behalf of the City of Montevallo.

Resolution 03312025-496

A Resolution authorizing the allocation of Montevallo Cooperative District Funds (MDCD) for the construction of a new gymnasium at Montevallo High School in conjunction with the Shelby County Board of Education.

WHEREAS, The current gymnasium at Montevallo High School was constructed in 1964 and has served the school's needs for indoor athletics, and student assembly, as well as, the needs of the City of Montevallo's youth basketball program and,

WHEREAS, the student population of Montevallo High School and the City of Montevallo's youth athletic program have grown to a level that necessitates expansion of gymnasium space and,

WHEREAS, the Shelby County Board of Education and the City of Montevallo have had a long standing agreement for the use of school athletic facilities for the City's youth athletic programs and,

WHEREAS, the Shelby County Board of Education has requested financial assistance from the City of Montevallo for the purpose of constructing a new gymnasium at Montevallo High School and,

WHEREAS, the Montevallo Cooperative District (MDCD) was established in 2012, in part, to promote economic development, recreation, and healthy and active lifestyles in Montevallo, via capital improvements and,

WHEREAS, the Montevallo City Council has considered and hereby declares the renovation and/or construction of a new gymnasium to be in the best interest of the public.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MONTEVALLO, ALABAMA AS FOLLOWS:

Section 1. That the Council hereby authorizes the allocation of funds by the Montevallo Cooperative District (MDCD) up to but not more than Two Million Dollars (\$ 2,000,000).

Section 2. That funding shall be made available in partial allocations as requested by the Shelby County Board of Education.

Section 3. The Montevallo City Council authorizes the Mayor, City Clerk and Treasurer to execute the required documents and fund transfers in an amount not to exceed \$2,000,000.00 and to negotiate a Memorandum of Understanding with the Shelby County Board of Education for the purpose of constructing the Montevallo High School Gymnasium.

Section 4. The expenditure of these funds shall be subject to the consideration of and approval by the MDCD.
