Mr. Lehman updated the Board on the proposed conduit installation along Main Street to terminate at boxes and lamp posts for future use. Mr. Prince made a motion to approve \$26, 592 from excess revenue for the installation of conduit in conjunction with the Main Street paving project. Chairman Woodham seconded the motion. The motion was approved by all with a two to zero vote.

Chairman Woodham made a motion to approve the minutes of the January 30 and February 27 meetings. Mr. Prince seconded the motion. The motion was approved by all with a two to zero vote. The minutes of October 5 and November 14 to be approved in the presence of Ms. Smith at a future meeting.

Mr. Prince made a motion to approve Chairman Woodham the authority to enter into an arbitrage agreement as part of the refinance of up to \$3500. Chairman Woodham seconded the motion. The motion was approved by all with a two to zero vote.

Mr. Gilbert updated the Board on the concept for the park in front of UMoM building. Father Nature will provide a conceptual design for committee review and approval followed by submission to the Board for recommendation to the City Council. Mr. Prince made a motion to approve \$1,200 for conceptual design work by Father Nature from the UMoM budget line item with the split to be determined at a later date. Chairman Woodham seconded the motion. The motion was approved by all with a two to zero vote.

Chairman Woodham stated she would like for the Board to consider holding off on additional project funding until the Main Street and Center for the Arts projects begin to firm up. She further suggested everyone in attendance should take a walk through Orr Park to see the bank restoration improvements.

Mr. Gilbert stated the city had an art show on the 22nd, a golf tournament on the 27th, and a survey from Main Street, AL will be distributed on April 1.
